Subject: Reframing and Publishing of Tentative/Provisional Seniority List of CPWs/LFPWs for inviting objections thereof.

NOTICE

Whereas Director School Education Kashmir Srinagar Vide Order No. 403 DSEK of 2021, Dated: 12-07-2021 constituted a committee of three members for absorption of CPWs and

Whereas in response to DSEK's Order, this office constituted a committee vide No: CEO/K/Est/1803-05/21, Dated: 15-07-2021 for scrutinization/verification of files of CPWs and

Whereas Director School Education Kashmir Srinagar Vide No: DSEK/NT/DPC/39-44/2019/All/1571-77, Dated: 08-10-2021 nominated one representative of Directorate of School Education Kashmir for conducting DPC of CPWs and

Whereas this office in light of Contempt Petition No. 387/2018 framed a fresh seniority list of CPWs and uploaded the same on office website of this office in year 2022 after completion of all formalities strictly as per list and files submitted by all Zonal Education Officers of this District.

Whereas this office accordingly conducted DPC of CPWs in 03 phases wherein 24 CPWs were accordingly regularized strictly as per norms/criteria and seniority and

Whereas this office received several representation from many CPWs/LFPWs and Zonal Education Officers wherein it was found that there are some CPWs/LFPWs who haven't been enlisted in Seniority List framed by this office in year 2022 due to one or other reasons and so many unqualified CPWs/LFPWs have been enlisted in the list and

Whereas this office in consultation with the Committee decided to reframe the seniority list keeping in view the chance to be provided to genuine left out CPWs/LFPWs after genuineness and other related documents to be submitted by concerned Zonal Education Officers with cause of delay also and to delete those names that have either been regularized/retired/died/unqualified/not considered by previous DPC for regularization etc. and

Now, in light of the above, a list of 658 CPWs/LFPWs is hereby published on official website of this office (www.ceokulgam.in) for invitation of objections if any within a period of 10 days along with documentary evidences duly countersigned/authenticated by Zonal Education Officers and submitted to this office accordingly. No objections after the expiry of the date will be entertained in any circumstances.

Further all Zonal Education Officer are directed to receive the list from this office and submit the same with the current status of the CPW/LFPW and a certificate to the effect that the details of the CPWs/LFPWs of their Zone falling in the said List have been cross checked/Verified and have been authenticated from their relevant records within a period of 10 days positively.
