- That the incumbents have completed required spell of 09/18/27 years as the case may be, satisfactorily and without any 2. interruption as defined in Rule 4(K) of SRO-14 dated:15.01.1996.
- That the incumbent was not under suspension or contemplated in any charge or charge-sheeted under classification control 3. and Appeal Rules 1956 or any other rules and his/her work and behavior has remained satisfactory.

- 11. That recovery of excess pay and allowance, if any, pointed out shall be attended on priority, while payment of arrears on a c of In-Situ promotion.
- 12. That there are no criminal cases proceedings pending against the above officials before any investigating agency viz:(VOK Crime branch) or court of law and the genuineness of appointment has been ascertained (established in respect of the employee/s.
