ORDER

Whereas, this office had issued Advertisement Notice No. CEO/K/NT/01/14/2048-50 dated 04.08.2014 inviting applications from eligible candidates of District Kulgam for appointment against Class-IV/MTS posts; and

Whereas, the District Level Selection Committee constituted under Government Order No. 735-GAD of 2008 dated 30.05.2008 read with Government Order No. 731-GAD of 2010 completed the selection process and prepared the select/wait list on the basis of merit and eligibility of the candidates; and

Whereas, the said selection process became subject matter of judicial scrutiny before the Hon'ble High Court in SWP No. 1888/2015 titled *Maria Nazir & Others Vs State of J&K & Others* and thereafter in LPA No. 109/2020 titled *UT of J&K & Others Vs Maria Nazir & Others*; and

Whereas, the Hon'ble Division Bench vide judgment/order dated 11.12.2020 directed the competent authority to examine the legality of the selection process and take a decision in accordance with law; and

Whereas, pursuant thereto, Government Order No. 1213-Edu of 2021 dated 28.07.2021 declaring the selection process void ab initio came to be challenged before the Hon'ble Central Administrative Tribunal and other competent forums; and

Whereas, the Hon'ble Central Administrative Tribunal vide order dated 24.11.2025 in O.A No. 1824/2021 titled *Suhail Afzal Dar Vs UT of J&K & Others* set aside Government Order No. 1213-Edu of 2021 and directed reconsideration of the matter in light of the judgment passed by the Hon'ble Division Bench in LPA No. 109/2020; and

Whereas, the matter was subsequently re-examined by the Administrative Department in consultation with the Department of Law, Justice & Parliamentary Affairs and after examining the entire record pertaining to the selection process; and

Whereas, the Government vide Order No. 147-JK (Edu) of 2026 dated 15.04.2026, while taking note of the legal opinion and judicial directions, has held that the selection process conducted by the then District Level Selection Committee appeared fair and merit based, and further ordered that the selection process be finalized notwithstanding the non-association of a nominee of the Directorate of School Education Kashmir in the Selection Committee; and

Whereas, the Director School Education Kashmir, in compliance to the aforesaid Government Order and judicial directions, has conveyed approval vide e-Office Comp. No. E-7887810, File No. DSEK/LS/164/2026-03 for issuance/finalization of the Final Selection List;

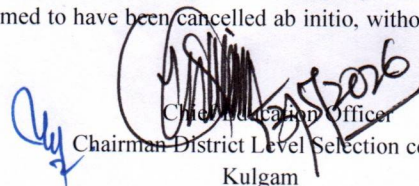
Now, therefore, in compliance to:

- the judgment/order dated 11.12.2020 passed by the Hon'ble Division Bench in LPA No. 109/2020 titled *UT of J&K & Others Vs Maria Nazir & Others*;
- the order dated 24.11.2025 passed by the Hon'ble Central Administrative Tribunal in O.A No. 1824/2021; and
- Government Order No. 147-JK (Edu) of 2026 dated 15.04.2026;

and in pursuance of the approval conveyed by the Director School Education Kashmir, the Final Selection List of candidates for appointment against Class-IV/MTS posts advertised vide Advertisement Notice No. CEO/K/NT/01/14/2048-50 dated 04.08.2014 is hereby issued as per **Annexure-"A"** appended to this Order, which shall form an integral part hereof, subject to the following terms and conditions:

Terms & Conditions

1. That all selected candidates shall be required to produce original certificates/testimonials including qualification certificates, category certificates, date of birth certificates, domicile/residence certificates, and other relevant documents before the competent authority for verification/authentication prior to issuance of formal appointment orders.
2. That appointment orders shall be issued only after successful verification of antecedents/character by the competent agencies and fulfillment of all codal formalities prescribed under rules and government instructions in force.
3. That mere inclusion of the name of a candidate in the Final Selection List shall not ipso facto confer any indefeasible right of appointment unless all prescribed formalities are completed to the satisfaction of the competent authority.
4. That this Final Selection List is being issued strictly in compliance to the judicial directions and Government Order No. 147-JK (Edu) of 2026 dated 15.04.2026 and shall not be construed as a precedent in any other case.
5. The selectee(s) shall mandatorily report to this office within 07 days from the date of publication of this list for submission of their V. Rolls and other relevant documents for verification/authentication, failing which it shall be presumed that they are unwilling to join the Department and have foregone the appointment. Consequently, their appointment shall be deemed to have been cancelled ab initio, without any further notice.
