Order no. 84-Edu of 2022 Dated:- 25/02/2022 and Govt. order no. 10-JK(Edu) of 2024, Dated:-01.03.2024 in its meeting held on 16.12.2024 and cleared by GAD (Vigilance), sanction is hereby accorded to the promotion and adjustment of following 02 (Two) Laboratory Assistants whose particulars are indicated against their names, as Teachers in the Pay Scale of Level-5 (29200-92300) in District Cadre Kulgam w.e.f 16.12.2024. boratory Assistant to the post of Teacher is subject to the fulfillment of following Explicit conditions: -

- 1. The promotion shall be without prejudice to the final outcome of the case, if any Sub-Judice or pending before the Hon'ble Court or any other Court and other orders, if any passed by the competent authority, which may not be immediately within the knowledge of this office.
- 2. If any Laboratory Assistant as named above in the promotion/adjustment order on subsequent verification found not eligible for such promotion, this order will not confer any right on him/her and his/her promotion to the higher post (made hereby) shall be rescinded automatically. It will be the responsibility of the DDO concerned to verify particulars of the Promotee with reference to his/her original service records and ensure that the date of 1st appointment as Laboratory Assistant as well as other particulars recorded against them (here in the order) are correct, variation if any found shall be brought into the notice of this office immediately. In that case the Laboratory Assistant shall not be relieved for his promotion on the higher post.
- 3. The officials must necessarily be holding substantive genuine appointment and uninterrupted service. The benefit of promotion shall not be allowed in a case the Promotee is under suspension or in case the departmental proceedings are pending against him or his work and conduct is not satisfactory.
- 4. The promotes shall report to their new place of postings within 21 days from the date of issuance of this order, failing which the promotion shall be deemed to have been cancelled ab-initio in his favour without issuing cancellation orders.
- 5. The official shall submit undertaking to the concerned DDO to the effect that in case his service particulars/Academic/Professional credentials/degrees found fake/forged/tempered or issued by an unrecognized university or the course is proved unrecognized at any stage, he shall have no claim on the promotion and the promotion shall be cancelled ab-initio without any further notice and the legal action as warranted under rules shall be initiated against him. The official shall further undertake that neither he is facing any criminal proceedings in any court of law nor he is having any criminal record.
- 6. The DDO must ensure that there is nothing adverse against him from VOK/Crime/Police/CID.
- 7. The DDO concerned before implementing the order must ensure that the qualification/category certificate(s)/appointment order of the Promotee has been verified and found genuine/correct.
- 8. Superior claim vis-à-vis inter-se placement of the Promotee for re-determination of seniority in the cadre of Laboratory Assistant, if any shall be submitted to this office within a period of one month through proper channel.
- 9. The promotee must necessarily join at their places of posting within a period of 21 days from the date of issuance of this order.
